SUBJECT: Changes to the New York State Certificate of Title (MV-999)

On December 15, 2008, the Department of Motor Vehicles began issuing a new Certificate of Title (MV-999). In many respects, the new title will look the same as the current version of the title document. The watermark, security fibers, and security thread features remain unchanged on the new design. The face of the new MV-999 differs slightly from the current certificate, as described below. NOTE: All titles issued previously are still valid.

- Seals. The New York State Coat of Arms in the upper left corner has been replaced by to the new DMV seal. The DMV "key" in the upper right corner and the New York State seal in middle of the document have been removed.
- Text. The DMV web address in the upper right corner has moved up. The new version date, shown in the lower right corner, is (4/08).

Attached is a sample of the new document with changes marked. Some of the background printing is not visible in this scanned attachment.
